Warranty Period

Archatrak warrants that adjustable height polyethylene paver supports sold by Archatrak under the brand name 'Eterno', 'Prime', 'NM', 'SE' will remain free from defects for a period of three (3) year from date of purchase.

Warranty Coverage

If any manufacturing defect should become evident within the specified warranty period, Archatrak will replace the defective paver support(s) free of charge.

Archatrak shall not be responsible for labor charges incurred for installing replacement paver supports and such charges are excluded from this warranty. Archatrak will also not be responsible if any pedestal support is installed with a visible manufacturing defect.

Warranty Claims

To make claim under this warranty, Archatrak must receive notification of the claim as soon as reasonably possible. You must notify Archatrak in writing by sending a description of the claimed defect together with proof of purchase to the following address:

Exclusions

Because specific installation details, structural design and environmental conditions are byond the control of Archatrak, no responsibility can be accepted due to:

- Abnormal stress imposed on the pedestal supports within ordinary use or in situations that do not comply with commonly accepted use of the pedestal supports.
- Installation of the pedestal supports in locations or for purposes that are deemed to be unsuitable by Archatrak.
- Defacing caused by foreign objects or materials.
- Mechanical or manual abrasion and abusive alteration.
- Damages resulting from improper installation or workmanship not in accordance with Archatrak's instructions or standard industry practice.

Limitations

This warranty is a limited warranty and shall constitute the full extent of Archatrak's liability on its warranty. This warranty is in place of all other warranties, expressed or implied, including the implied warranty of merchantability and the implied warranty of fi tness for a particular purpose.

Under no circumstances will Archatrak be liable or obligated for any incidental, consequential, indirect, special, punitive or any other damages of any kind whatsoever (including, but not limited to, lost profits, lost sales, loss of goodwill, stoppage of work, or impairment of assets), whether foreseeable or unforeseeable, arising out of breach or failure of express or implied warranty, breach of contract fraud, misrepresentation, negligence, strict liability in tort or otherwise, except and only to the extent this limitation is specifically precluded by applicable law of mandatory application.
